Thank you for clarifying the situation. To avoid further confusion, the Inspector has asked that any communication in relation to these representations is submitted via yourself, as you remain the nominated agent. The Inspector has agreed to accept the written submissions, but please see her further comments below.

The sessions that you are currently listed to appear at reflect our email exchanges in recent weeks. The request to appear at additional sessions has been made at a very late stage and is disruptive to the Inspector's preparation for the hearings and may also cause inconvenience to other participants. Furthermore, the Inspector is disappointed to note that the written submissions received from Kingsley Smith have not sought to address the main matters and issues identified by her as required by the Guidance notes which were sent to you on 18 April 2012. Rather than addressing the Matters and Issues, the written submissions deal with three specific sites, under the title *Promotion of land at....* As the Inspector has previously indicated, the Core Strategy Examination is not the place for detailed consideration of individual sites.
